**Important Information Regarding Makeup & Hair Services**

All services are priced and include the use of professional products and supplies. The rate does not include headpiece, hair accessories, and flowers.

**MAKEUP SERVICE-**Make sure your face is cleaned and moisturized prior to ensure that makeup holds all day long. However we will moisturize again. Stay hydrated and drink plenty of water the week of your wedding and the wedding day!

**HAIR SERVICE-**Please make sure everyone receiving hair services arrive with clean, dry hair, product free, preferable to of been washed within 1 day to help hold hairstyle or up-do please do not wash your hair on the same day. **\*\*If anyone in the bridal party arrives with wet hair will need to blow dry their hair completely prior to services. Unless otherwise booked in advance if time permits and blow drying services is needed prior to style you will be charged \$50 per blow dry\*\***

**\*\*Add ons\*\*** If any additional person(s) request hair and or make up services on the wedding day, it is at the discretion of JoJo Maguire based on time and schedule availability.

Clip In Extensions (If Applicable) you are responsible for selection extentions that are heatable and clips already attached to bundles of hair.

Trials are available for bride and all members of the wedding party for an additional \$100. This fee includes make up to include lashes & 1 hair style. Each additional hair style added is \$50 per style.

On the wedding day, the bride must communicate the importance of being on time and properly prepared. Every person getting their hair done in an up do, half-up style, or curls must have their hair washed preferable the night before and blown dry as this gives the best texture to style. All hair must be straight but not flat ironed, unless extra curly hair desires a smooth style. If such a case arises, the stylist will charge extra of \$50.00 to blow dry (if time permits) or the service will be forfeited and the charge will still apply.

On location at venue, the stylist(s) needs a designated space to set up when on location. The bride is responsible for clearing an area before the stylist(s) arrives. The stylist(s) will need a work area with a chair near an outlet in a no walk-through traffic area. Good light or natural light is preferred. If services cannot be performed due to insufficient work conditions or tardiness, all fees still apply. The stylist will not be held liable for any injuries that should arise while on location.

\*\*\* Please make sure to wear a button down shirt to allow for changing without disruptions to hair style or make up application.\*\*\*

Additional makeup for touch-ups: Lipstick, lip gloss, blush & powder, will be available for purchase on wedding day for anyone that would like to have these items for touch ups.

## **POLICIES, TERMS, AND CONDITIONS**

1. DEPOSIT POLICY: A minimum payment of \$100 non-refundable fee to secure the date. The \$100 fee will go towards your wedding services and will be deducted from the final balance due date.
2. Travel: \$.50 per mile, round trip from address of artist-

3. A stay late fee of \$50 per hour, begins after the ready by time. If you are interested in having me stay past get ready time for an touch ups, please make sure to include in contract amount due.
4. CHANGES OR CANCELLATION POLICY: You may change or cancel your services giving a writing notice only. In the event of cancellation before 60 days of the event

date there will not be any extras charges. Your holding fee will not be refunded. If changes or cancelations are made with less than 60 days' notice: the entire cost of the services will be placed on the credit card provided in contract. We do ask that should there be a need to adjust or cancel any of previously booked service, that changes are made 30 days priors to the wedding date appointment. Please note, to book your date we accept PayPal or Venmo payments to pay booking fee for bridal services.

- 5. **PAYMENT: On the day of the event: we accept CASH or Venmo payment to JoJo Maguire Designs ONLY. If time permits, any additional members in party wanting to have services done will be added to total.**
- 6. Credit Card Information: A valid credit card is required to hold your date and will only be charged should there be a balance day of for any services received.
- 7. Possible Hotel Fee- If an overnight stay is required due to start time or location, you agree to provide a hotel room at your hotel or within 5 miles of ready location for the artist.


